GENERAL COMMENTS

On December 29, 2022, I conducted an inspection of the Back Nine Freshwater Impoundment in Somerset Township, Washington County.

The disturbed repair areas remain temporary stabilized.

I observed what appeared to be additional third party disturbance on the slope behind the impoundment.

I recommend that the operator continue to document third party disturbances within the LOD.

No accelerated erosion or sedimentation observed.

New violations added for the failure to submit NOT prior permit expiration.

Violation 102.22(a) remains outstanding.


